

www.swiss-people-cash.ch (SPC)

SPC is the Swiss population's new weapon against the unbelievable **coronavirus and possibly other pandemics**. All official decisions generate bitter opponents and supporters. I only hear noisy chatter, while a large part of our population is in need and our businesses and so on are going to the dogs!

With the new **swiss-people-cash**, we can receive much-needed and very welcome help. SPC is a non-refundable **gift from the entire Swiss population** to the many people, companies and institutions suffering from coronavirus.

Let's be honest: since the beginning, many have already learned a lot, have made good and bad decisions, but – and this is particularly tragic – no one in this world knows for how long coronavirus will cause us sleepless nights, pain and death. Far too many businesses have already closed their doors and very soon there will be many more. It's **never been worse**. That's why right now we need

a courageous and effective restart!

This is an emergency! By the end of January at the latest, I will be sending around 2500 emails to Bundesbern and all institutions in politics, health and pharmaceuticals and many production companies, and to friends and acquaintances. Then everyone who knows this page can use my website www.swiss-people-cash.ch - which is written in the four national languages - to express their approval for, or rejection of, this request. The average cross-language evaluation result can **be read off in seconds**.

This is not about physical health, that is what professionals are responsible for. No, it's about mental and financial health.

... and about damage prevention, or damage reduction in pandemics **during** a partial or total loss of sales and / or income, caused by officially ordered total or partial shut-downs and their direct consequences. Those affected can be: **offices, businesses of all kinds, the self-employed, in particular restaurants, hotels, leisure organisers, sports, artists, the entertainment industry and also employees, etc.** (not an exhaustive list).

And this is where it gets interesting:

SPC is a new parallel currency to be introduced that will not burden the National Bank in any way. We will vote on it and hopefully win. **And then it will work like this:** all requests for help arriving at SPC result in a total amount each day. SPC has the money required for this produced by a banknote printer (Orell-Füssli etc .) with approval from the Federal Council. The latter delivers the banknote directly to the National Bank in favour of the SPC account. No profit should result from SPC – it is only redistributed. SPC has a flat hierarchy and only pays the average wage according to the Swiss Commercial Association. The “big boss” receives 150% of the average staff wages. The workforce is continuously adjusted to meet requirements.

If you **want to** get help, you can register online with the (new) federal company **SPC**, on whose website a simple form can be filled out with the desired requirements. SPC automatically informs the following official and specialist offices on the same day (via software):

1. the responsible debt enforcement office of **stops on any debt enforcement** actions up to 30 days after the end of the lockdown in question. Translation French
2. landlord (s) or mortgage creditors (and their refinancers) of **immediate interruption of** payments until revoked by SPC. Translation French
3. all suppliers notified by those seeking help about **immediately effective deferment** of payment of outstanding supplier invoices until the end of the business closure.

An entitlement to financial help is also extended to

4. Anyone who already paid AHV last year and no longer has the same income as immediately before the pandemic due to company closure or short-time work, etc. With immediate effect and by means of monthly payments, they will receive 80% of their income from unemployment insurance (at the instigation of SPC) from the unemployment insurance company - tax-free.
5. All “interim solutions” (distance learning via video transmissions and the like) must be requested by letter – using examples giving percentages of income and loss of income and requested in a non-bureaucratic but plausible manner. SPC pays 80% of this in monthly instalments until the end of the company's closure – tax-free.
6. Services payable annually that cannot be used during a company closure are extended by the duration of the company closure.

Warning: Anyone who abuses the **SPC** community system, which is built on **total trust**, will be severely punished – **with jail terms of no less than 5 years** . The purpose of this threat of punishment is to create a very high level of inhibition against fraud (a publicly-prosecuted criminal offence). Every request for help from SPC must involve a confirmation to be clicked separately that this threat of punishment has been "understood".

It is again a matter of **many billions**. However, Switzerland is so immeasurably rich that even many billions evaporate like a drop on a hot stone. I assume that this “swiss-people-cash” cannot be saved by the recipients, as they immediately use the money to cover the living costs. An increase in the tax rate is also ruled out, as tax authorities can also request help from SPC.

swiss-people-cash will flow back into the economy practically immediately and in turn generate taxes and fees of all kinds. I do not expect inflation to rise significantly either.

Of course, these suggestions still need to be refined, checked and discussed.

swiss-people-cash will be introduced for five years for the time being and will be extended for another five years if the process is satisfactory.

We all hope that this difficult time will be overcome quickly and that the often-abused nursing staff will remain with us at least until they are inevitably rewarded according to

their circumstances and risks. Looking at the hospital bills that are (for the time being) **3-6 times too expensive**, which are additionally “garnished” with lavish **hospital financing**, this should have happened a long time ago. Typical "Management Floor" behaviour

Change of subject:

As early as December 3, 2018, I had the **website domain** "Gesicherte-AHV" reserved - probably with the thought that eventually one would have to go through the books again.

As soon as I have time for another initiative, **swiss-people-cash** will also play a decisive role here. The referendum on May 19, 2019, in which the **AHV reform** was linked to **financial reform**, was clearly unlawful because of the violation of the constitutional principle of “unity of subject matter” - that our parliament allowed this.. **hair-raising!**

For all readers who do not know what the term “**unity of subject matter**” means: in a referendum on two different topics, voters must be able to say yes or no to each topic or abstain from voting. But this was not possible when only one yes or no was permitted!
